# Conferences, Seminars, Lectures & Exhibits

In August, the Institute for Peace and Justice **Education** organized a two-week "Summer School on Conflict Prevention and Transformation" in collaboration with the UN. This residential program brought together thirty university students from several Lebanese universities as well as three universities in the USA. Academics from Lebanon, the USA, the UK, Canada, Italy and Germany provided students with knowledge about the nature of conflict, root causes of violent conflict and challenges of post-war reconstruction. Participants explored causes of the Lebanese civil war, ethnicity and communal polarization. They also heard personal testimonials of reconciliation. During hands-on training-sessions, students developed skills of interpersonal conflict resolution, negotiation and mediation. The program was sponsored by the UN, LAU, the Swiss Embassy, the Royal Norwegian Embassy, Banca di Roma and Sohat. The Centre for Strategic Development provided logistical support to the Institute for Peace and **Justice Education.** 

On October 13, the two-week Photography Exhibit <u>Celebrating Black & White</u> was opened at Sheikh Zayed Gallery in the recently rededicated Safadi Fine Arts Building (Beirut) in the presence of President **Joseph Jabbra**, Deans **Samira Aghacy** and **Tarek Na'was, Arts and Communication** Chair (Beirut) **Mona Knio**, photography instructor **Albert Saikaly**, and students and guests. The exhibit included works of students from last year's Photography I/II classes.

On November 24, the **Division of Electrical and** 

**Computer Engineering** (School of Engineering and Architecture, Byblos) held a presentation seminar to announce the implementation of a new software system called "Power System Simulator for Engineering" (PSS/E). This system is the most widely used tool for electric transmission system planning and operation: it is used by more than 90% of electric utilities worldwide. Through the efforts of Dr. Raymond Ghajar, five licenses of the software valued at approximately \$150,000 were donated by Power Technology Inc. (PTI) of Schenectady, New York to LAU to train students and help them find better jobs. LAU is currently the only university in the Middle East to have this software which will be used in power engineering courses. The presentation was attended by President Joseph Jabbra, VPAA Abdallah Sfeir and the faculty of the School of Engineering and Architecture. Two PTI executives were in attendance: the donor Mr. Elie Nasr, Head of Business Development (USA office), and Mr. George Rizopoulos, Head of Consulting Services (UK office). Mr. Elie Nasr, whose wife and sister are both LAU alumni, indicated that he made this gift to Lebanese students to help them get a better education and to encourage them to stay in Lebanon for professional fulfillment.

On December 3-4, the **School of Business** (Beirut) held its annual <u>Finance and Accounting International</u> <u>Conference (FAIC 2004)</u> on the timely issue of "Managing Securitization for Lebanon and the MENA Region" in Irwin Hall Auditorium, Beirut (<u>www.lau.edu.lb/securitization</u>). event acted as a symbiosis between the Business School's academic teaching and industry practice in finance, bridging the gap between the two for the benefit of all. On December 3, after opening statements by Dr. Michel Majdalani (Co-chair of the FAIC 2004 Organizing Committee), Dr. Abdallah Sfeir (VPAA) and Dr. Tarek Mikdashi (Dean of the Business School in Beirut), the floor was given to two distinguished keynote speakers: Dr. Ahmad Jachi (First Vice-Governor of the Central Bank of Lebanon) and Dr. Nasser Saidi (former Minister of Economy). The December 4 session was opened by Mrs. Janine Zacca (Co-chair of the FAIC 2004 Organizing Committee). Speakers represented the IMF, the World Bank, the University of Georgia, The Royal Bank of Scotland, Orrick International, Cambridge University, HEC Lausanne, Moody's, Citibank, Banque Audi, BSEC, and the Lebanese Ministry of Finance. Ninety-eight attendees from the institutional sector (among whom the representatives of more than twenty local and regional banking institutions and finance houses) actively participated in the conference along with LAU faculty, students and alumni. A gala-dinner in the Bristol Hotel. Beirut, was held in honor of the guest speakers, event sponsors, faculty members and

participating professionals on December 3. FAIC 2004 was covered by the news media in more than a dozen local and regional newspapers and magazines, positioning LAU's **School of Business** as one of the leading academic institutions with such synergistic capabilities. In addition, six industry magazines sponsored the conference, thus enhancing LAU's public relations' image in the field. Organizers **Michel Majdalani** and **Janine Zacca** were able not only to self-fund this conference but also to contribute to the University's main funds by raising more than \$14,500 in institutional money.

The **Humanities Division** (Beirut) initiated the new academic year with two well attended lectures in the context of the <u>Role of Literature in Contemporary</u> <u>Society Lectures Series</u>. On November 9, in collaboration with the British Council, seasoned British novelist Lawrence Norfolk (winner of the prestigious Somerset Maugham Award) gave a talk titled "Holding up the Mirror, While Standing on One's Head". Mr. Norfolk's witty presentation drew many probing questions on the writer's role, inspiration and responsibility from an interested audience composed of faculty and creative writing students.



On December 16, Lebanese novelist Rashid al-Daif was the second guest of the **Humanities Division** (Beirut) in the conference rooms of Irwin Hall. The title of his talk (in Arabic) was "For Whom I Write." A professor at the Literature Faculty of the Lebanese University (1<sup>st</sup> Branch) with numerous scholarly articles to his credit, Rashid al-Daif has authored eleven novels, three volumes of poetry, and a book of tales. His work has been translated into nine languages. His most recent novel, <u>Mabud yanjah fi Baghdad</u> (Mabud Makes the Grade in Bagdad) is now on sale. (Mr. al-Daif was featured with a photograph in the previous issue of the <u>Faculty Gazette</u>.)

Dr. Hugh Busher of Leicester University, UK is the principal supervisor abroad of LAU's **Doctorate Program in Education**. He was the guest of the **Education and Social Science Division** (Beirut) on November 24 in Irwin Auditorium. Dr. Busher's lecture entitled "Leaders, Values, and Social Justice: Improving Teaching" was attended by an audience of more than 250, including LAU faculty as well as Lebanese School Principals.

On December 9, the Education and Social


**Science Division** (Beirut) hosted Professor Walter Russell Mead, Kissinger Senior Fellow in US Foreign Policy at the Council on Foreign Relations. Professor Mead is a leading expert on US foreign policy and on the role of the USA in world politics, with many publications in the field to his credit. The topic of his talk was "Power, Terror, Peace and War: America's Grand Strategy in a World at Risk."

In the context of the Contemporary Scandinavian Architects Lecture Series, the **Department of** Architecture & Design (School of Engineering & Architecture, Byblos) offered two talks by leading Danish architects. Jorgen Sondermark from the firm 3xNielsen (www.3xn.dk) lectured on November 30 in Irwin Auditorium, Beirut, and Louis Becker from the firm Henning-Larsens-Tegnestue (www.hlt.dk) spoke on December 2. Both firms are at the cutting edge of innovative Scandinavian design, having created concert halls, schools and educational facilities, office buildings and residential projects in Europe, Asia and elsewhere in the world. The lectures were attended by faculty, students, graduates of LAU and other schools, as well as by professionals from the various design fields.

Joseph F. Khalife, professor and music coordinator in Byblos, composed and organized three concerts in the 2<sup>nd</sup> half of 2004: a welcoming concert in October, a Fall concert in November and the Christmas concert in December. In Beirut, Ms. Leila Dabaghi organized the musical setting of the Commencement exercise as well as the annual Christmas concert. It merits special mention that for several years now, the LAU Choir (Beirut), directed by Ms. Dabaghi, has participated in the "Talented Friends of the Al Bustan Festival in Concert" program. For example, in the September 2004 version, the LAU Choir presented, to great applause, "The Prologue" and "The Capulet's Ball" from Gounod's <u>Romeo and Juliet</u> as well as four other works by European composers.

**Dima Dabbous-Sensenig** gave a paper entitled "Arab Cultural Policies and the Protection of Cultural Diversity in WTO Negotiations" at the conference on <u>Global Broadcasting, Cultural</u> <u>Diversity and Regulation</u> which was held in Barcelona, Spain as part of the UNESCO sponsored Universal Forum of Cultures (May-September).

During the summer vacation, **Ruth Maalouf** and **Tarek Khoury** (**Graphic Design**, Byblos) organized a study trip to London for twenty graphic design students. Besides museum visits and theatre productions, the program included visits to major exhibitions and five major graduation shows of British graphic design students, namely at the Royal College of Art, Camberwell College of Art, Surrey College of Art, Central School St. Martin's, and London University. Students described the experience as "really great" and "a discovery of incredible design." On December 20-24, the Byblos **Graphic Design Division** launched an exhibition to share

the London experience with fellow students, friends, faculty and family. The exhibition, which included photography, video footage and poster design, showed how students moved from one environ-



ment to another, and in this transition the viewer can see the relationship and the diversity between their home country and the foreign city. The Division intends to schedule another trip in Summer 2005.

<u>The 7<sup>th</sup> International University</u> <u>Theatre Festival</u> took place in Irwin and Gulbenkian theatres and outdoors at the Beirut campus, July 22-29. It hosted 48 participants from Yale University (USA), Sultan Qaboos University (Oman), the High Institute for Theatre Arts (Kuwait), King Fahd University for Petroleum and Minerals (Saudi Arabia) and the High Institute for Theatre Art (Tunisia), along with other universities in Lebanon. LAU-Beirut students gave four productions, while LAU-Byblos students performed musical skits. The A Capella singing group "Whiffenpoofs" from Yale University presented two performances in collaboration with LAU and the US Embassy, and the LAU Music Club gave three concerts ("After 12," Arabic music, and Jazz). Ziad Sahhab played the oud, and Zei Khauli gave a solo dance performance. Students from the Lebanese University (1<sup>st</sup> Branch) gave a solo dance and a short mime performance. A seminar on "Prospects for a Future Theatre" brought together Drs. Ahmad Sakhsoukh (Cairo), Rida Bou Qaddida (Tunisia), and, from Lebanon, Jean Daoud, Mashour Moustapha and Najat Tawil. This

varied and successful festival was directed by Drama professor **Maurice Maalouf** (Byblos) and drew a total audience of approximately 2000.

On August 10, **Huda Ayyash-Abdo** gave a presentation at Brasenose College, Oxford University, UK in the context of the <u>Oxford Symposium for School-</u> <u>based Family Counseling</u>. The topic of her paper (to be published in the <u>Proceedings</u>) was "Reality and Opportunity: School-based Family Counseling in Lebanon."

On September 22, **Ketty Sarouphim** presented her paper "Diversity in Education: Crisis or Opportunity?" at the <u>1st Conference</u> of International Consultants organized by the Trinity Institute for Christianity and Culture, London.

Sami Baroudi gave a paper entitled "Lebanon's Maronites' Many Voices: The Divergent Perspectives of President Camille Chamoun and Patriarch Paul Meouchi during the 1958 Lebanese Crisis" at the Annual Meeting of the Middle East Studies Association (MESA) which was held in San Francisco, California (November 20-22). Dr. Baroudi presented his paper in a panel on "Lebanon in the Sectarian Imagination."

**Mona Nabhani** was selected by the National Commission for Lebanese Women to participate in a workshop offered by the Arab Women Organization in Cairo in preparation of a national survey related to women in the fields of education, media, economics and health. No fewer than twelve Arab countries participate in this project, and four Lebanese professionals representing as many fields were invited. In the field of education, Dr. Nabhani will conduct a survey of all projects and studies done in Lebanon between 1995 and 2005 by all types of organizations (academic, governmental, NGOs, civil societies, religious groups, international organizations) concerning women on such subjects as life skills, literacy, technology and continuing education. Following the survey, Dr. Nabhani will select the most successful projects, analyze them, and present recommendations for implementing similar projects in the other eleven Arab countries at a meeting scheduled to be held in Cairo in April 2005.

In Fall 2004, **Habib Malik** became a founding member in Lebanon of the Local Societies Initiative (LSI) of the Metanexus Institute based in Philadelphia, which is funded by the Templeton Foundation. LSI aims to promote dialogue between science and religion. In addition to taking part in regular discussion sessions within the local LSI branch with scientists, theologians, philosophers and historians of ideas Dr. **Malik** is involved in producing a television series of discussions in English about the science-religion debate, starting February 2005 on TéléLumière satellite television. A first introductory roundtable discussion included Eric Weislogel of the Metanexus Institute, Edward Alam (NDU) and Richard Khuri (LAU). Dr. Malik also already hosted two hour-long episodes on the general topic of astronomy and religion, and specifically on the implications of astronomical discoveries for theology and the Christian faith; in the first of these episodes he hosts **Richard Khuri**, a philosopher of science, and in the second Yousef **El Hage**, a physicist and member of the Pontifical Council for Inter-religious dialogue.

# Flashes from Centres and Institutes

Representing the Institute for Peace and Justice, Irma Ghosn

was invited to speak at a conference organized by Women's Initiative for Peace (WINPEACE) and the Greek Centre for Research and Action on Peace (KEDE) in Athens, on October 16. The conference topic was Integrating peace education in the Greek school system: Changing attitudes, behavior and structures conducive to violence.
